PERMISSION TO ARRANGE LICENSE

I. THE AGREEMENT

The parties specifically acknowledge that the Arrangement, at all stages of development, shall be considered a Work Made For Hire, as contemplated and defined in section 101 of the United States Copyright Act as in effect on the date of this letter agreement, and as may be amended from time to time hereafter, as a specially ordered and commissioned work prepared for publication as a secondary adjunct to a work by another author.

To the extent, if at all, that the Arrangement is determined not to be a Work Made For Hire, the Licensee, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, hereby assigns, sets over, transfers, and conveys to the Publisher all right, title and interest the Licensee may have had, now has, or hereafter may have in and to the Arrangement, including without limitation any and all copyrights and copyright rights therein arising under the laws of each territory of the universe, to have and to hold absolutely for the full term of each and every such right including any renewal, reversion, extension, restoration, or revival now existing or hereafter created or discovered.

III. DESCRIPTION OF THE ARRANGEMENT

IV. LICENSE TO REPRODUCE

Provided that the Arrangement is used only in connection with a performance by the Institution on the aforementioned date(s), and that such performance is done without any purpose of direct or indirect commercial advantage, the Licensee and/or the Institution shall be permitted to produce no more copies than is necessary to facilitate the preparation and rehearsal of the aforementioned performance(s). In consideration of the foregoing grant, the Licensee shall pay to Tapspace **USD \$250**, the receipt of which, along with the completed and signed back page of the Agreement, shall complete execution of this Agreement.

V. RESERVATION OF RIGHTS

All rights in and to the Arrangement, except as specifically granted to the Licensee herein, are hereby reserved by Tapspace for the Tapspace's use. The Licensee specifically acknowledges that no right to record or reproduce additional copies is granted by Tapspace herein except to create one (1) archival copy of your performance(s) for review and educational purposes. Any such further reproduction, recording, and/or distribution of the Arrangement shall be by a separate permission upon the Licensee's written request, and at the discretion of Tapspace. The Licensee shall not further distribute, sell, loan, lease, and/or rent the copies of the Arrangement made pursuant to this letter agreement to any third party for any purpose whatsoever.

VI. CREDIT

This agreement constitutes the entire understanding of the signatories concerning its subject matter, shall not be amended except in a writing signed by all of the signatories hereto, and shall be interpreted according to the internal laws of the State of Oregon.
